- (ix) Persons with Disability: Competent Authority to issue a Disability Certificate shall be a Medical Board duly constituted by Central or State Government consisting of at least three member out of which at least one shall be specialist in the particular field for assessing Locomotor/Cerebral/Visual/Hearing Disability, as the case may be and should PRODUCE AT THE TIME OF DOCUMENT VERIFICATION FAILING WHICH THEIR CANDIDATURE WILL BE CANCELLED.
